**STATUTORY CONSULTATION:
Proposals to relocate Milltimber School, to a new building to be constructed
within the Oldfold Farm development**

I am writing with details of the Council's proposals to construct a new primary school building within the Oldfold Farm development at Milltimber, and to relocate Milltimber School to this new building following its completion.

It is expected that building work for the proposed new school at Oldfold Farm will be completed in 2021, and it is proposed that all pupils registered at Milltimber School will move to the new building at that point.

The consultation process, which has started today, Monday 22 April 2019, will therefore focus on the proposal set out below, and your comments on this are most welcome.

Proposal:

To relocate the existing Milltimber Primary School to a new building on an identified site within the Oldfold Farm development, with effect from August 2021 or as soon as possible thereafter.

The period of statutory consultation for this proposal will conclude on Friday 7 June 2019.

All submissions should be received by 5.00pm on Friday 7 June 2019. A public consultation meeting to discuss the Council's proposal will be held on Wednesday 29 May 2019, at Milltimber School from 7.00pm to 8.00pm.

Following the consultation, a report will be presented to the Education Operational Delivery Committee. This will include a summary of all representations received during the consultation period, including representations made at the public meeting, along with the Council's responses to those representations. It is at this stage that the Committee will make a final decision on whether to implement the Council's proposal.
